CEO Drees addressed the Board of Directors and requested the Kern County Coronavirus Relief Fund Program Assistance to Special Districts Agreement be added to the Agenda. Upon motion by Director Allred, seconded by Director Balentine, The Board approved the agenda with a 4/0 vote.

A. Resolution Amending Board Policy 300 As It Relates to Authorized Positions and Compensation.

CEO Drees briefed the Board on the new CA minimum wage effective January 1, 2021; stating the revision is needed to increase several positions that start at minimum wage. CEO Drees also stated the Fire Dept. positions are no longer needed since the airport signed a Five (5) year contract with Pro-Tec which started today. Upon motion by Director Allred, seconded by Director Parker, the Board approved the Resolution Amending Board Policy 300 with a 4/0 vote.

B. Relocation Reimbursement with Commitment Authorization

CEO Drees Briefed the Board about the prospective candidates for Air Traffic Controllers, stating most are from out of state and other competitors offer a Relocation Package. CEO Drees explained she wants to offer a package that will span several years which will also help with retention in staff. Directors Balentine and Deaver voiced their agreement with the plan.
