Background:

The Mojave Transportation Museum (MTM) have offered to the District two homebuilt aircraft for display, one Rutan VariEze and one Rutan Long-EZ. Through joint coordination with MTM and MASP, Terra-Gen have offered funds to facilitate the display of these two aircraft inside the SOW Event Center. MASP Staff have provided a conceptual drawing of the display and if approved will obtain all necessary permits and inspection for display of the aircraft inside the Event Center.

Recommended Action:

Staff recommend the board authorize the CEO to execute the loan agreement for the VariEze and Long-EZ and approve the concept for display of both aircraft in the Stu O. Witt. Event Center.

AIRCRAFT DISPLAY AGREEMENT

This agreement is made as of March 5, 2024, between The Mojave Transportation Museum Foundation, 16922 Airport Blvd., Room 1, Mojave, CA 93501 ("Owner"), and Mojave Air & Space Port, 1434 Flightline, Mojave, CA 93501, a California Airport District ("MASP").

1. Owner hereby loans to the MASP the following Aircraft for permanent display by MASP:

AIRCRAFT	TAIL NUMBER
1) Rutan VariEze	N27RG
2) Rutan Long-EZ	N202EZ

- 2. The Aircraft will be displayed at the Stuart O. Witt Event Center, 1247 Poole St., Mojave, CA 93501, by [describe how aircraft will be displayed/Pending detailed description]. MASP agrees to not display the Aircraft at another location without prior written permission from Owner.
- 3. MASP agrees to accept the Aircraft on an "as is, where is" basis, and to be responsible for all arrangements and assume and pay all costs, charges, and expenses incurred in displaying the Aircraft.
- 4. MASP will keep the Aircraft in a neat and clean manner while displayed, and will repair any damage to the Aircraft that occurs while the Aircraft is on display, but MASP is not responsible for any other maintenance or repair of the Aircraft and is not responsible for returning the Aircraft in a condition better than it was received.
- 5. MASP obtains no interest in the Aircraft by reason of this agreement, and title shall remain in the Owner at all times. Any requirements, modifications, or additions on or to the Aircraft must be approved in writing by the Owner.
- 6. MASP agrees to display a placard with the Aircraft that contains the following credit line: "This aircraft is on loan from the Mojave Transportation Museum Foundation of Mojave, California." Additionally, articles published or submitted for publication by MASP, or websites that refer to the Aircraft, must credit the MTMF as owner of the Aircraft.
- 7. MASP agrees not to use the Aircraft as security for any loan, hypothecate, encumber, sell, lease, rent, or exchange the Aircraft for monetary gain or otherwise, under any circumstances. Owner must approve in writing any assignment or loaning of the Aircraft to any other person.

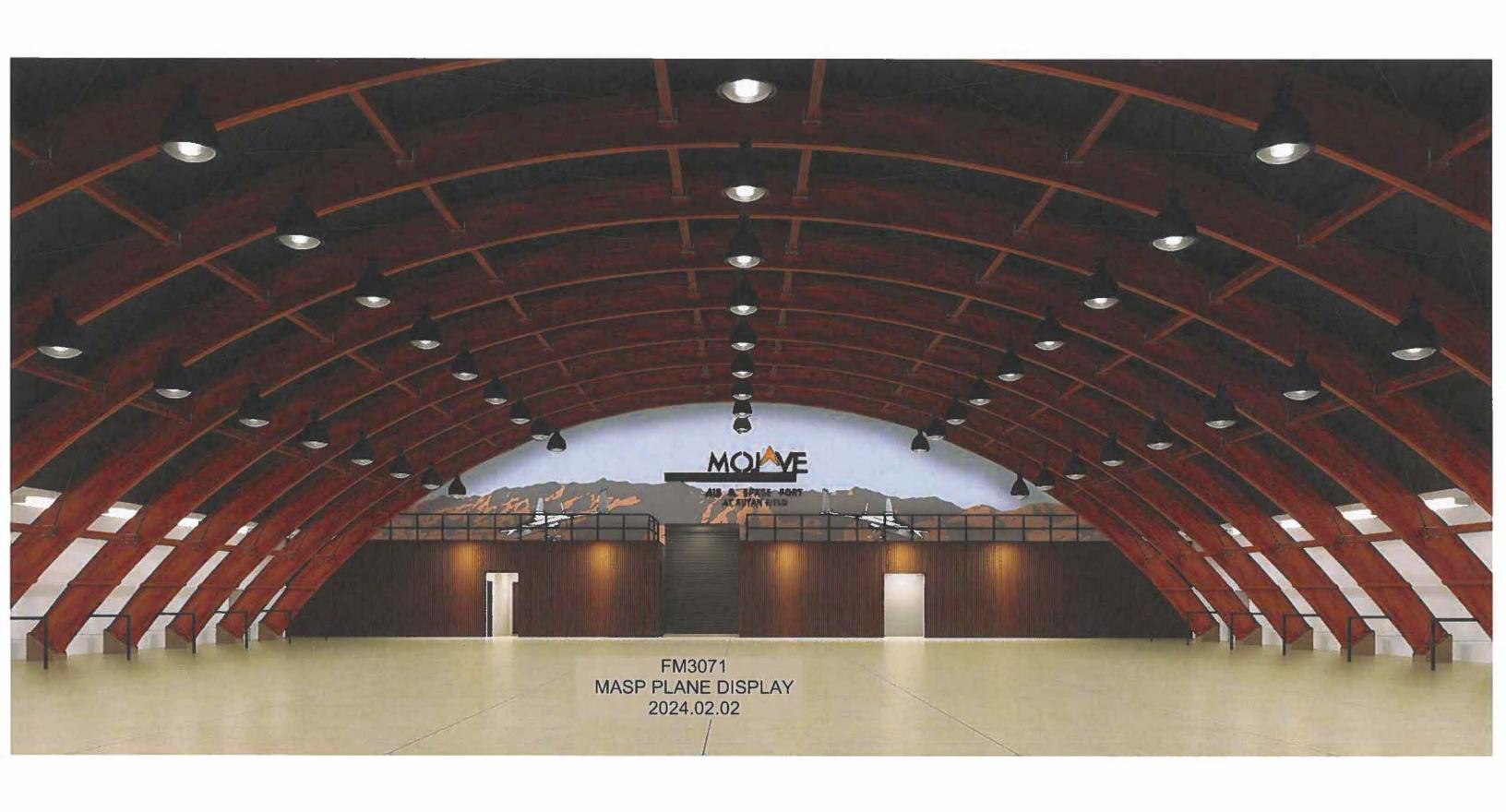
- 8. MASP agrees to allow authorized representatives of Owner reasonable access to the Aircraft to ensure compliance with the terms of this agreement.
- 9. MASP agrees to indemnify, hold harmless, and defend the Owner from and against all claims, demands, actions, liabilities, judgments, costs, and attorney's fees, arising out of, claimed on account of, or in any manner predicated upon personal injury, death, or property damage caused by or resulting from MASP negligence or intentional misconduct.

Owner agrees to indemnify, hold harmless, and defend MASP from and against all claims, demands, actions, liabilities, judgments, costs, and attorney's fees, arising out of, claimed on account of, or in any manner predicated upon personal injury, death, or property damage caused by or resulting from Owner's negligence or intentional misconduct.

10. This agreement may be terminated by either party upon 90-days written notice, and MASP agrees to return the Aircraft to the Owner on termination, or earlier, if it is determined that the property is no longer required.

Updates

- → Taxiway A Electrical Rehabilitation Contract executed February 20th, however due to the lead times for the lighting fixtures there will be a delay. MASP is working with Royal Electric to reduce the overall delay of the project by switching out work required on the ramp (replacing ducting and cabling for all the home runs) to the first phase, while waiting for the delivery of the light fixtures.
- → Inland Port Update No update.
- → Water Main System Update Construction began last Monday (February 26) and is currently affecting Roper Street. The project will last approximately 30-days with minimal impact to GA gate access and roads. Project update meetings held each Tuesday at 10:00 am.
- → Water System Hydraulic Modeling DOF Floyd has made more progress with obtaining information from our tenants, will start scheduling meetings with the remaining tenants to wrap up data collection over the next few weeks.
- → **Hangar Development Update** Working with Local Equity to address questions about the proposed project.
- → GA Complex Maintenance
 - Crack repairs completed in the southeast taxi lane adjacent to hangars 969-934 and west of hangar 959. We will schedule additional crack repairs west of hangar 973 after April 16th.
 - o Rain gutter project anticipated to be completed by March 8th.
- → Airfield Clean-up of the runway safety area for 8/26 completed west of TWY E, with the remainder to be completed in April. Biennial wind cone maintenance and new windsocks installed.



CEO REPORT

→ Highlights:

- Updated State Senator Shannon Grove on the airport's needs and efforts. She is aware of our concerns about transitioning to unleaded avgas.
- ACA Board is actively lobbying the State of California to transition to unleaded avgas when it is COMMERCIALLY available.
