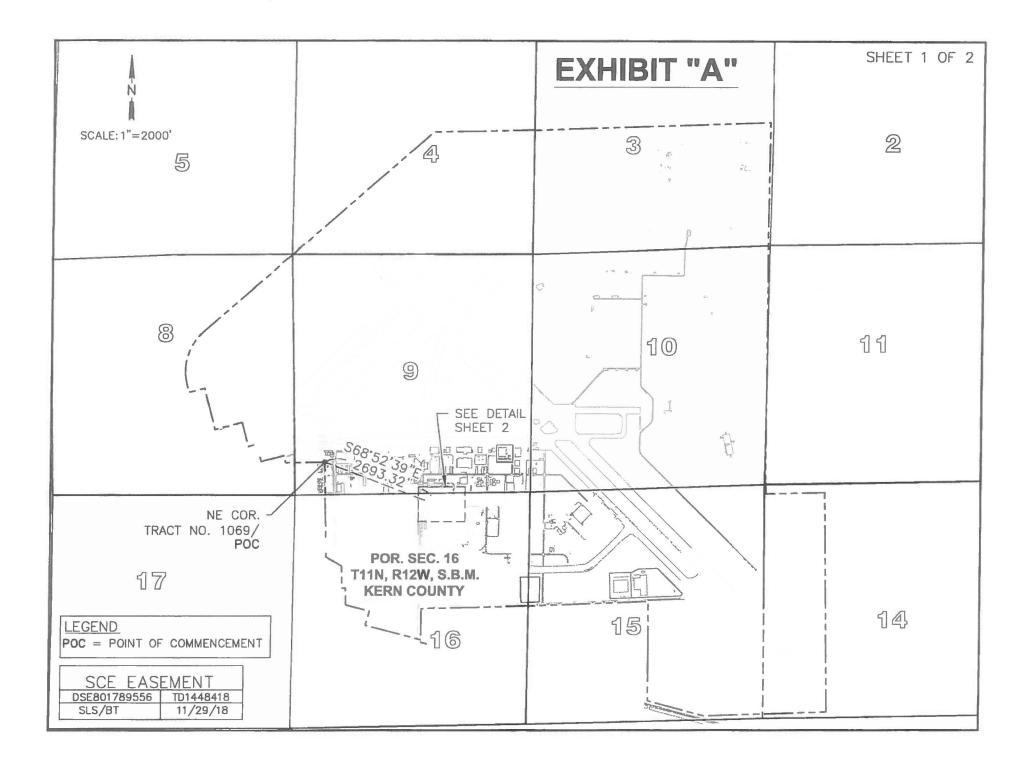

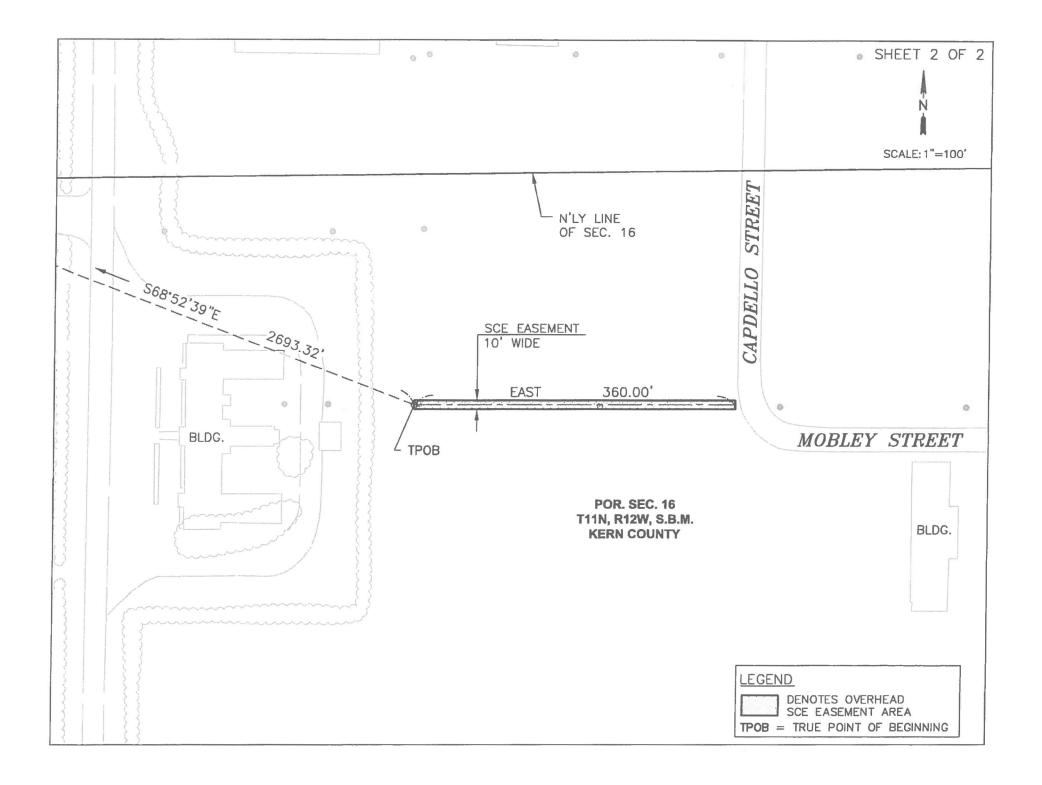

- I hosted FAA personnel from the runway safety group December 13. They witnessed Virgin's flight and toured the Stratolaunch facilities, as well as our control tower to see if there may be future funding options for the airport.
- I will meet with the LA Airport District Office (ADO) Wednesday, December 19 to discuss future airport infrastructure projects.

Discussion Item

 AB2329 - On August 20, 2018, the Governor signed AB2329, which amends the enabling legislation of several types of special districts to increase the maximum monthly compensation of board members for attending meetings, and annually increase the maximum monthly compensation thereafter. Beginning January 1, 2019, the airport district may adopt a policy allowing board members compensation for attending up to six meetings per calendar month at the same rate. The policy must describe why the additional meetings are necessary for effective operation of the district. Beginning January 1, 2020, the Board may choose to increase compensation by 5% per year.
